Keynote Address

**School Psychologists: Competence, Capacity, and Opportunities for Children,
Families and Schools**

At the same time, potential threats related to the economic environment, job security, credentialing, roles and functions, and other issues require school psychologists to ensure our competence and protect our capacity to contribute to children's learning and mental health. The presentation will focus on the many strengths of school psychology---and school psychologists---to respond effectively and promote our successful future.

Workshop Description

- A. Ethical Principles for School Psychologists: A Problem-Solving Approach** (Note: 8 AM start)

This workshop will provide participants with skills and strategies to enable them to use a problem-solving model to effectively interpret ethical principles in school psychology. This problem-solving approach can be applied as school psychologists encounter ethical and legal issues in their work settings, with the goal of avoiding ethical violations and protecting the rights and welfare of children and advocating for their best interests. Using actual cases, the workshop will provide examples of behaviors that would comply with standards of appropriate professional conduct. Instruction strategies will include lecture, guided discussion and practice in applying the problem-solving model. Participants will earn 3 CEUs to fulfill the ethics and professional practice requirements for NCSP renewal.

- B. Promoting and Preserving School Psychology (AM only)**

C. Best Practices for Improving School Climate: Purpose, Engagement, and Voice (PM only)

To a greater and greater extent, school psychologists will find that they can establish considerable value for themselves, and benefit for their schools' academic achievement, by developing interventions to improve school climate. This workshop will focus on techniques used by the Developing Safe and Civil Schools (www.teachSECD.com) team to improve climate through enhancing students' sense of purpose, classroom and academic-linked techniques to foster student engagement, and interventions through service learning and student government that increase student voice.

D. Linking Assessment to Intervention: Interpretation and Use of WJIII RPI (PM only)

The Woodcock Johnson III Normative Update (WJIII NU) Tests of Cognitive Abilities and Tests of Achievement provide a wide variety of scoring options for interpretation of an individual's test performance. These include scores such as standard scores, percentiles, age equivalent, and grade equivalents. These scores allow you to make normative comparisons to peers. However, two of the scoring options, Relative Proficiency Index (RPI) and W-score, can be used to measure an individual's progress over time. This presentation is intended to facilitate the understanding of psychologists about the following: The development of the RPI and W-Score; the differences in the type of information provided by "peer" comparison scores such as standard scores and that provided by the RPI and W Score; the reasons for any differences seen between a child's standard score and RPI on a given subtest/cluster; the clinical and educational utility of the RPI and W-Score with measuring progress; intervention development, and eligibility. An overview of the Woodcock Interpretation and Instructional Intervention Program will be provided demonstrating linking assessment results to intervention.

E. Breaking the Silence: Making America's Schools Safe (PM only)

This interactive workshop outlines the implications that name-calling has on students, educators, and communities. Psychological, educational and physiological outcomes are discussed for racial and sexual minority youth. Furthermore, direct versus non-direct discrimination is compared as it relates to educational settings. This workshop provides empirically-based interventions for policy, programming and practice issues for educators and service providers in order to decrease name-calling and increase school safety. Participants will be able to 1) Discuss the psychological, educational, and physiological impact that name-calling has on students; 2) Identify policy and programming changes that effectively increase school safety; 3) Utilize Implementation Intentions as it relates to practice issues to empirically decrease name-calling.

F. Providing Comprehensive Assessment Driven Interventions to Students with Higher Functioning Autism

Spectrum Disorders: A Guide for School-Based Practitioners (Full Day)

As growing populations of students with higher functioning Autism Spectrum Disorders (ASD) enter schools, school psychologists are increasingly called upon to assist with educational planning and support. The purpose of this workshop is to provide school psychologists with practical information for creating and implementing various assessment driven strategies that contribute significantly to the growth of children with ASD in a variety of educational settings. Specifically, this workshop will provide participants with knowledge of "how-to" enhance academic, social, and behavioral outcomes of students with higher functioning ASD. Topics of discussion will include: (a) recent advances in neuropsychological research, (b) teaching academic content, (c) incorporating social goals in the classroom, and (d) planning for behavioral success. Specifically, this workshop will focus on environmental and social support strategies, as well as academic modifications to accommodate student needs. Ultimately, participants in this workshop will return to their respective work environments with practical and effective solutions for educating children with higher functioning ASD.
